「2024 第一屆臺灣國際模擬聯合國會議」簡章

一、活動緣起

模擬聯合國(Model United Nations,MUN),是一項國際學術交流活動。全球許多國家、城市和學校都有自己的模擬聯合國俱樂部或舉辦過相關活動。臺灣重視多元化教育和國際融合,也開始透過青年論壇和研討會舉辦模擬聯合國會議。臺灣近百所大學和高中成立了模擬聯合國俱樂部,突顯了模擬聯合國的重要性。在模擬聯合國中,參與者扮演非本國代表的角色,參與談判和討論。參與者須扮演不同國家的外交官、跳脫個人的視角,站在本國的立場看待問題。他們必須仔細判斷決策將如何影響國家利益,考慮國家的立場,發表聲明並模擬政策。最後,參與者必須與其他國家的代表進行談判以達成共識。

本活動由財團法人商業發展研究院、中華民國台灣模擬聯合國協會、龍騰文化股份有限公司共同主辦,旨在透過模擬聯合國討論培養學生的國際視野、同理心和跨文化溝通技巧。透過模擬國際會議程序,學生可以了解程序規則的重要性,培養國際知識、技能和國家使命感,並增強國際競爭力。學生將作為外交官分析國際時事,訓練批判性思維、反思、多元化視角以及參與全球行動的能力。

活動為期兩天,包括三場模擬會議。第一天包括開幕式、訓練課程和第一次模擬會議。培訓課程將介紹模擬聯合國,讓參與者熟悉議會程序、研究和資料收集技術,並練習起草會議文件。第二天包括第二次和第三次模擬課程,以及國際禮儀實踐課程。所有會議和課程結束後,將舉行合影、閉幕式和頒獎典禮。所有三個會議主題均與永續發展目標(SDGs)一致,並與聯合國和國際委員會的主題相關,重點關注優質教育、性別平等、社會保障、糧食資源和氣候變遷。

二、主協辦單位介紹

(一) 財團法人商業發展研究院

財團法人商業發展研究院(Commerce Development Research Institute,下稱商研院)為國家級服務業研發智庫,基於「建立服務業發展基石,創造高品質、高附加價值之服務業創新能量並整合資源,加速服務業知識化,提升國際優質競爭力」之成立宗旨。隨著國內服務業活動發展趨勢已朝向商品精緻化、分工專業化、經營創新化與國際化之模式。商研院以「前瞻、創新、國際化」三大主軸,作為產、官、學、研間相互支援的平台,引進各界能量與鏈結資源,為政府提供政策建議,並為服務業者提供全面解決方案,開創服務業的新藍海。

商研院長期參與國際經貿組織活動,且積極地投入參與聯合國貿易便捷化與電子商務組織 UN/CEFACT 相關計畫,以直接的行動參與全球制訂相關數位經貿的規範標準,與我國民

間專家及各國專家合作參與聯合國 UN/CEFACT 永續觀光商業標準白皮書計畫,共同完成第一版白皮書制訂。

(二)中華民國台灣模擬聯合國學會

中華民國台灣模擬聯合國學會(MUN Society Taiwan,下稱台灣模聯學會)於 2021 年成立,為全國性學術性社團,立志推行模聯、創造國內社群連結,並為臺灣學生創造接軌國際之機會。學會由就讀於國立陽明交通大學、國立臺北大學、國立臺灣大學和其他大專院校的學生組成。2021 年時疫情肆虐,模擬聯合國社團活動大受打擊,團隊成員們開設了免費的模擬聯合國線上課程和工作坊,吸引了上百位高中職及大學生參與。看到疫情對全球學生活動的衝擊,他們以「讓臺灣三年內成為全球模聯佼佼者」為目標,創立了此學會。2024年3月,學會成功主辦了全球最大、被譽為模擬聯合國奧運盛事之稱的「哈佛世界模擬聯合國」(Harvard WorldMUN),來自世界約 50 國、約 1000 位國際大學生前來臺北市,參與為期 5 天的國際性會議。

(三) 龍騰文化事業股份有限公司

龍騰文化事業股份有限公司(Longteng Education Co., Ltd.,下稱龍騰文化),是國內知名的教育出版公司,專注於高中職多個學科的教科書、參考書及教學資源的編輯與發行。自成立以來,憑藉其專業的編輯團隊和嚴謹的出版流程,迅速成為臺灣教育出版市場的領導者之一。公司注重教材的創新與實用性,致力於提供最佳的學習資源,幫助教師提升教學效果。

- (三) 藉由扮演外交使節分析國際時事,建立學生批判、反省、多角思考與參與全球行動的實踐力。

七、活動方式

- (一) 論壇採模擬聯合國的方式進行討論,著正裝並以全英文發表,仿效聯合國及相關國際機構,遵循國際會議的議事規則,針對全球議題進行討論。
- (二) 會議中,主辦單位將擔任主席與司儀主持會議,參與者須扮演他國外交官,模擬他國立場,藉由公開演說闡述代表國家的立場、透過辯論或遊說整合各國意見並執行大會議事規則實踐民主投票,最後再模擬撰寫決議文。
- (三) 參與者需於填寫報名表單時上傳「參加動機」PDF 檔,以利主辦方認識參與者及進行篩選。

字數限制:使用英文撰寫 500 字以內。

字體樣式、大小及行距: Times New Roman 字體,字體 12pt,行距 1.5 倍行高。

- (四) 兩天全程參與者將頒發參加證書。
- (五) 第二天會議結束後將進行國際禮儀實務課程,並於課程結束後頒發精美紀念品與各式獎項,獎項包含最佳國家代表獎新臺幣 3,000 元 3 名、優秀國家代表獎新臺幣 1,000 元 6 名、最佳發言人獎新臺幣 3,000 元 3 名、優秀發言人獎新臺幣 1,000 元 6 名,共 18 位名額,共計新臺幣 30,000 元。
- (六) 會議資訊:
 - 1. 會議類別:採用模擬聯合國議事規則進行,共3個英文委員會,共3場會議。
 - 2. 主席人數:每個委員會計3位主席。
 - 3. 參加代表:採雙人代表混合單人代表方式進行,每場會議 35~40 組代表,共計70人。

八、預計討論主題

議事主題扣合全球永續發展目標 (SDGs),並結合聯合國及相關國際議會委員會主題,選定有關優質教育、性別平權、社會安全、糧食資源、氣候變遷等議題,說明如下:

- (一) 議題:公共衛生危機對政府的經濟挑戰(The Economic Challenges of Public Health Crisis To The Governments)
 - 議題類別:公共安全風險管理 (Public Safety Risk Management)
 - 委員會:世界衛生組織(World Health Organization, WHO)
 - 議題介紹:2019 年爆發的新冠肺炎在各方面都造成了重大的影響,尤其是對全球經濟的衝擊。供應鏈中斷、企業倒閉、失業率上升等問題都使得各國政府面臨沉重的經濟負擔。參與者應針對此議題展開討論,探討當公共衛生發生重大危機時,對商業和經濟造成的連鎖反應,並深入研究如何透過經濟政策、企業支持措施以及國際合作來緩解這些挑戰。
 - <u>相關 SDGs</u>: SDG 1 終結貧窮 (No Poverty)、SDG 3 健康與福祉 (Good Health and Well-Being)、SDG 8 合適的工作及經濟成長 (Decent Work and Economic Growth)
- (二) 議題:戰爭與衝突對全球經濟穩定的影響(The Impact of Wars and Conflicts on Global Economic Stability)
 - 議題類別:國際安全與人道主義 (International Security and Humanitarian Affairs)
 - 委員會:聯合國人權理事會 (United Nations Human Rights Council, UNHRC)
 - 議題介紹:俄烏戰爭、以巴衝突、蘇丹內戰、剛果內戰……,世界各地至今衝突、 戰爭不斷,不僅對人道主義造成了嚴重影響,也擾亂了全球經濟的穩定。供應鏈中 斷、能源價格波動、國際貿易受阻等問題,給全球市場帶來巨大壓力。參與者應探 討戰爭以及衝突所帶來的問題如何影響全球經濟,並且討論如何透過國際合作、經 濟制裁及其他手段避免事態更加嚴重以及防範同樣的問題再度發生。
 - 相關 SDGs: SDG 8 合適的工作及經濟成長(Decent Work and Economic Growth)、SDG 9 工業化、創新及基礎建設(Industry, Innovation and Infrastructure)、SDG 16 和平、正義及健全制度(Peace, Justice and Strong Institutions)
- (三) 議題:綠能發展對全球經濟的促進作用 (The Economic Benefits of Green Energy Development)
 - 議題類別:環境永續性(Environmental Sustainability)
 - 委員會:國際再生能源組織(International Renewable Energy Agency, IRENA)
 - 議題介紹:隨著全球對環境保護意識的提升,綠能產業成為各國經濟發展的新引擎。太陽能、風能和水能等可再生能源的應用,不僅有助於減少化石燃料的使用,還能創造大量就業機會、推動技術創新,並促進經濟增長。參與者應討論綠能發展對全球經濟的積極影響,並提出促進綠能產業發展的政策建議,包括稅收優惠、投資激勵以及國際合作等方面。
 - <u>相關 SDGs</u>: SDG 7 可負擔的潔淨能源 (Affordable and clean energy)、SDG 8 合適 的工作及經濟成長 (Decent Work and Economic Growth)、SDG 9 工業化、創新及基 礎建設 (Industry, Innovation and Infrastructure)



2024 1st Taiwan International Model United Nations Meeting (TIMUN)

1. Background of the Event

Model United Nations (MUN), is an international academic exchange activity. Many countries, cities, and schools worldwide have their own MUN clubs or have held related activities. With an emphasis on diversified education and international integration, Taiwan has also begun organizing MUN conferences through youth forums and workshops. Nearly a hundred universities and high schools of Taiwan have established MUN clubs, highlighting the importance of MUN.

In MUN, participants play the role of representatives from countries other than their own, engaging in negotiations and discussions. By acting as diplomats from different countries, participants must step out of their usual perspectives and view issues from the standpoint of their assigned country. They must carefully judge how decisions will impact their country's interests, consider their stance, make statements, and simulate policies. Finally, participants must negotiate with representatives from other countries to reach a consensus.

This event is co-hosted by the Commerce Development Research Institute (CDRI), the Model United Nations Society Taiwan (MST), and the Longteng Education Co., Ltd. (Longteng Education). It aims to foster students' international perspectives, empathy, and cross-cultural communication skills through MUN discussions. By simulating international conference proceedings, students can understand the importance of procedural rules, strengthen their international knowledge, skills, and sense of national mission, and enhance their international competitiveness. Acting as diplomats to analyze international current affairs, students will develop critical thinking, reflection, diverse perspectives, and the ability to participate in global actions.

The event lasts two days, including three simulation sessions. The first day features the opening ceremony, training sessions, and the first simulation meeting. Training sessions will introduce MUN, familiarize participants with parliamentary procedures, research and data collection techniques, and practice drafting meeting documents. The second day includes the second and the third simulation sessions, and a practical course on international etiquette. After all the meetings and course, there will be a group photo, closing ceremony and the awards ceremony.

All three session topics align with the Sustainable Development Goals (SDGs) and are related to themes from the United Nations and international committees, focusing on quality education, gender equality, social security, food resources, and climate change.

6. Participants and Number of Participants

- Priority admission:
 - With CEFR C1 (or equivalent English proficiency test) or above English proficiency
 - Students in gifted/talented programs in each school
 - Recommended by school
 - Departments related to diplomacy and international affairs
 - Related club experiences

7. Event Format

- The meeting will follow the Model United Nations format for discussions, wear formal suit and conducted entirely in English, simulating United Nations and related international organizations, adhering to international conference procedures, and discussing global issues.
- During the conferences, the organizer will serve as the chairman and emcee, and participants will play the role of diplomats from other countries, simulating their positions, making public speeches to articulate their country's stance, debating or lobbying to integrate opinions, and implementing conference procedures to practice democratic voting, and finally, drafting resolutions.

- Participants are required to upload the "Motive for Participation" PDF file when filling out the registration form to facilitate the organizer's understanding of the participants.
 - Word limit: Within 500 English words.
 - Font style, font size and line space: Times New Roman, size 12, 1.5 lines.
 - <u>Content</u>: May include but is not limited to motivation for participation, participation in international affairs or Model United Nations, club experience, and personal perspectives on the three topics.
- Participants who complete the two-day event will receive a participation certificate paper.
- After the conference on the second day, a practical course on international etiquette will be conducted, and souvenirs and various awards will be awarded after the course, including 3 Best National Representative Awards with NT\$ 3,000, 6 Outstanding National Representative Awards with NT\$ 1,000, 3 Best Spokesperson Awards with NT\$ 3,000, and 6 Excellent Spokesperson Awards worth NT\$1,000, a total of 18 quota, totaling NT\$ 30,000.
- Meeting information: The meetings will follow the Rule of Procedure of Model United Nations. There are 3 meetings in total, each meeting has an English committee, and each committee counts 3 chairs. The meeting is held in a double-representative mixed single-representative format, with 35 to 40 groups of representatives per committee, 70 people in total.

8. Discussion Topics

3 topics will be discussed during the two-day event. The discussion topics will align with the global Sustainable Development Goals (SDGs) and combine themes from the United Nations and related international councils, covering issues such as quality education, gender equality, social security, food resources, and climate change. The topics are as follows:

Topic 1: The Economic Challenges of Public Health Crisis to The Governments

- Category: Public Safety Risk Management
- Committee: World Health Organization (WHO)
- Introduction: The outbreak of the COVID-19 pandemic in 2019 has had significant impacts in various aspects, especially on the global economy. Issues such as supply chain disruptions, business closures, and rising unemployment rates have placed heavy economic burdens on governments worldwide. Participants should discuss this topic, exploring the chain reactions in business and the economy caused by a major public health crisis, and delve into how economic policies, business support measures, and international cooperation can mitigate these challenges.
- Related SDGs: SDG 1 (No Poverty), SDG 3 (Good Health and Well-Being), SDG 8 (Decent Work and Economic Growth)

Topic 2: The Impact of Wars and Conflicts on Global Economic Stability

- Category: International Security and Humanitarian Affairs
- Committee: United Nations Human Rights Council (UNHRC)
- Introduction: The Russia-Ukraine War, the Israeli-Palestinian conflict, the Sudan civil war, and the Congo civil war......, conflicts and wars continue to erupt around the world, causing severe humanitarian crises and disrupting global economic stability. Issues such as supply chain disruptions, energy price fluctuations, and obstacles to international trade exert enormous pressure on the global market. Participants should explore how the problems brought about by wars and conflicts affect the global economy, and discuss how international cooperation, economic sanctions, and other measures can prevent the situation from worsening and avoid similar issues from recurring in the future.
- Related SDGs: SDG 8 (Decent Work and Economic Growth), SDG 9 (Industry, Innovation and Infrastructure), SDG 16 (Peace, Justice, and Strong Institutions)

Topic 3: The Economic Benefits of Green Energy Development

- Category: Environmental Sustainability
- Committee: International Renewable Energy Agency (IRENA)
- Introduction: With the rising global awareness of environmental protection, the green energy industry has become a new engine for economic development in various countries. The application of renewable energies such as solar, wind, and hydropower not only helps reduce the use of fossil but also creates numerous job opportunities, drives technological innovation, and promotes economic growth. Participants should discuss the positive impacts of green energy development on the global economy and propose policy recommendations to promote the development of the green energy industry, including tax incentives, investment incentives, and international cooperation.
- Related SDGs: SDG 7 (Affordable and Clean Energy), SDG 8 (Decent Work and Economic Growth), SDG 9 (Industry, Innovation, and Infrastructure)
