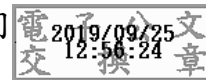

The abstract must be submitted **by December 1st 2019**. The announcement of abstracts that have been accepted for presentation will be by no later than December 5th 2019.

Paper Submission Guidelines

Papers should include a title, name(s) and affiliations of all authors, and be in MS Word format. Postal address, telephone number and e-mail address of the author(s) are also required. The paper must be submitted by **February 22nd 2020** (including references, notes, and tables, if any)

electronically to sdavn@uel.edu.vn. The font should be Times New Roman. The text of the paper should be in 12pt font, single space. All accepted papers will appear in the proceedings.
